5. Earnest Money / Security Deposit is to be deposited by way of bank demand draft drawn in favour of "THE PRINCIPAL SAINIK SCHOOL KORUKONDA" payable at "SBI SAINIK SCHOOL KORUKONDA BRANCH (SBI CODE No.2791)".

Security Deposit to be deposited by successful Tenderers by way of Bank Demand Draft at the time of accepting of contract when offered by school. Security Money is refundable on successful completion of contract period without any interest subject to submission of No Demand Certificate (NDC).
9. Last date for submission of sealed Tenders & to the Principal Sainik School Korukonda is **1600 hrs on 21 Aug 2025**. Sealed Forms should be sent either by Registered Post or personally may be dropped in the Tender Box which is kept at the outside of the Principal's Office Sainik School Korukonda duly marked on the top of the envelope **"Tender for Hair Cutting Services and Shoe Repair Services"** (Not to be opened before **21 Aug 2025 at 1630 hrs**).
10. As per school rules and regulations, the contractor should enter into contract agreement and also required to pay the necessary 3% security deposit on total bid value as mentioned above by Bank Draft to the school at the time of entering contract.
11. Income Tax will be deducted at source from all contractors as per rules of Income Tax from time to time. Please note that school will accept no cost escalation attributable to Tax deduction. Contractors themselves will claim refund of TDS, if any from the department of Income Tax. The Tenderers will enclose Xerox copies of GST/Tin number, Aadhaar Card, PAN number, Bank Account Number and other relevant E payment details like IFSC code No, Bank Name with address, Bank code (MICR) etc with tender forms.
